Beginning in March, parents/grandparents with knowledge of the process will work with the students to educate them all that's involved and assist them with collecting and processing the raw liquid. If the students can enjoy a pancake breakfast with the syrup they made, the project will be considered a success.

FCS Experiment: growing bacteria - Ms. Jamie Biller and Ms. Brittany Smith

The purpose of this Grant is to allow an experiment for family and consumer science students to find out which locations in the kitchen and types of foods contains the greatest amount of bacteria. Students will hypothesis within their lab groups which items they believe to contain the most bacteria. Then they will collect and label samples from different locations in the kitchen such as countertops, tables, handles, and floors or other items such as the hands and cooked vs. uncooked foods. We will be looking at collected bacteria in a petri dish filled with agar. During each day of the unit, students will report on what the samples look like and how much growth is seen within the colonies.
